Vulnerable sectors such as tourism and retail may be eligible for loans up to \$50,000. These flexible loans have partial grants, extended loan terms and are interest-free for 24 months. This loan cannot replace or duplicate government or other bank/lender emergency financing/funds that is available to businesses in Canada.
